

## **4° TROFEO GHISLERI PARTICULAR REGULATION**

The Club "A. GHISLERI" of Trieste and under the auspices of FIPSAS of the Province of Trieste is organizing a competition of Fin-Swimming in open sea for 800 m. which is named "4° TROFEO GHISLERI". The competition is open to male and female fin-swimmers of the 1<sup>st</sup> and 2<sup>nd</sup> category. The expected journey of 800 meters will take place in front the Barcola coast.

### **INSCRIPTION**

All athletes, members of clubs associated to FIPSAS and foreign competitors, members of clubs associated to CMAS who are in compliance with their inscription and with the medical control for 2006.

The inscription must be made to Club "A.GHISLERI" – 34145 Trieste (Italy) – Via Pisino n° 10 within 19.00 p.m. of 14 September 2006.

The entry fees are € 5,00 (five/00.-) per athlete. These fees can be sent with the entry-form or be paid directly on Sunday 24 September 2006.

Foreign teams (athletes and one team-manager) will be accommodated for the night of Saturday, September 23 2006 in the "Ostello Tergeste A.I.G.", Viale Miramare 331 since the "Ostello Tergeste" accommodates only 38 guests priority will be given depending on the entry date.

The participants of the 1<sup>st</sup> and 2<sup>nd</sup> category must be at the Judges disposal at 11.30 a.m. in Barcola.

At 11:45 shuttle transfer to the starting point.

Female competition will start at 12.00 a.m., male competition will start at 10.30 a.m.

### **PRIZES**

For THE CLUBS: THE 4° TROFEO GHISLERI will go to the club with the first arrivals without distinction of category nor ladies or gentlemen.

Individuals: 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> absolute placement men and women: medals  
1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place men and women of the 1<sup>st</sup> and 2<sup>nd</sup> category and beginners: cups.

The youngest competitor and the first Triestino classified: plates.

All participants will receive a commemoration medal. The prizes will be handed c/o the Club Sirena at the Terrapieno di Barcola
