41° TROFEO "UGO VOLLI" REGULATION

The "A. GHISLERI" Club Trieste, under the auspices of the Italian Federation of Sporting Fisching FIPSAS, organizes the 41st International Long Distance Fin-Swimming Competition of 4500 m. This competition is called TROFEO "UGO VOLLI" and is open to male and female finswimmers of 2nd, 3rd category, junior, senior and master.

ENTRIES: Entries will be accepted for members of associations affiliated with the FIPSAS and for foreign competition who belong to associations affiliated with the CMAS, according to the rules and circulars regarding fin-swimming competition issued by the FIPSAS. All entries have to be made on the special forms and must arrive at the centre of "A. GHISLERI" – 34145 Trieste, Via Pisino n° 10, Tel.040/382968 fax 040/382968 within 07.00 p.m. of 14^{th} September 2006.

All athletes, members of clubs associated of FIPSAS and foreign competitors, members of clubs, associated to CMAS who are in compliance with their inscriptions and with the medical control for 2006.

The entry-fee is €10,00 (ten/00.-) for each participant and € 15,00 (fifteen/00.-) for each Club. These fees can be sent with the entry-form or be paid directly on Sunday 24 September 2006.

Foreign teams (athletes and a single team-manager) will be accommodated for the night of Saturday, September the 23th 2006, in the "Ostello Tergeste A.I.G.", Viale Miramare 331 since the "Ostello Tergeste" accommodates only 38 guests. Priority will be given depending on the registration date.

COURSE: The competition will be held over the distance of 4500 mt in the open sea from Grignano Mare to Barcola. In case of strong Bora wind the traditional alternative journey in direction of Santa Croce will be decided. All participants have to be at the Judge's disposal from 08:30 a.m. of 24 September 2006 at the meeting point in Barcola.

EQUIPMENT: All the equipment contemplated by National Regulations for FIN-Swimming Competition may be used.

DURATION OF THE COMPETITION: The competition will be declared as ended one and a half hours after the men's start.

RESULTS: The final individual results will be determined by the time of arrival of women and men. The results of category will obtained by taking out the athletes in order of their general placement. The absolute results will be determined by taking into consideration the three best placements for men and two best placements form women of 2nd, 3rd category, junior and senior of each club.

The sum of the individual scores CMAS will determinate the result of the men's and women's Club, to which the CMAS scores ad foreseen will be added. The sum of the scores obtained by the placements of the men's and women's Club will determinate the general placement of each Club.

The absolute results will be determined by taking into consideration the three best placements for men and the two placements for women of the master A - B - C category.

The sum of the placements will determinate the general placement of club master.

PRIZES:

Clubs: The 41st TROFEO "UGO VOLLI" will be assigned to that Club which will obtain the first placement in the general placement for Clubs of 2nd, 3rd category, junior and senior up to the third place. One cup will be assigned to the first place of the men's Club and one to women's Club. Prizes will be given to all man's and women's Club up to the fifth placement.

One cup will be assigned to the club which obtained the first placement in the general placement for clubs master. Prizes will be given to all club up to the fifth placement.

a) the best absolute placement men and women: medal. Single:

b) 2nd and 3re absolute placement men and women: medals. c) 1st, 2nd and 3rd absolute placement 2nd, 3rd category, juniors, seniors master men and women will receive cups.
